Minutes of a WORKSHOP of the governing body of the City of Bruceville-Eddy held on the 11th day of October 2018, at 5:30 p.m. in the City Hall at 143 Wilcox Drive, Eddy, Texas

- 1. Call to Order; Opening Remarks: Mayor Connally Bass.
- 2. Roll Call: Mayor Bass, Mayor Pro Tem Wilcox, Councilmen F. Holt, A. Trigg, J. Dean, G. Lucas City Engineer J. Tabor, City Administrator K. Billings, Code Enforcement Officer Frank Warren.
- 3. Discussion of all agenda items listed. No action was taken.
- 4. Adjournment was at 6:20 pm.

Minutes of a 6:30 pm Council Meeting, held on October 11th, 2018.

- A. Call to Order: Mayor Connally Bass called the meeting to order at 6:33 pm.
- B. Prayer and Pledge led by Councilman Jason Dean.
- C. CITIZEN TIME: No one asked to speak
- D. CONSENT AGENDA:
 - I. Consideration was made to approve A/P for General/Water Funds for September 2018, the final budget moves for the year and the minutes of September, 2018 by a motion, made by Jason Dean, a second was made by Allen Trigg Frank Holt and an All in Favor vote cast.
- 1) City Engineers/Public Works: Report/Considerations. Report given by City Engineer, Johnny Tabor. Update was made regarding the Discharge Permit from TCEQ. Also discussion of update on the Drought Contingency Plan which will approve the 2020 five yr. period of Drought planning and will need to be updated every five years. The ordinance being considered is 10-2020-01. This will not be finalized until 1-1-2019, which is the earliest that the ordinance update for 2020 can be submitted to TCEQ. The number has been changed as requested by previous legal counsel. A motion to approve the Ordinance, which is not final until 1-1-2019, for the Drought year plan 2020 was made by Jason Dean, seconded by Gary Lucas. All ion Favor.
- 2) Police Department: Ms. Billings presented for consideration a resolution that is necessary in order for the police budget to receive a grant cash award. This was not done at the start up period and is retroactive for the dates covered by the police grant NRIM grant number 3275801. Motion to approve resolution number 3275801 made by Gary Lucas, seconded by Frank Holt. All in Favor.
- 3) Council considered a variance request made by A. Garcia, to place a trailer home at 110 Pinto Lane. During the discussion it was brought to the attention of Mr. Garcia that there was no meter on the land, nor was there a possibility to have one placed there until current water projects are completed that would increase the pressure in the area. The request died from Lack of Motion.
- 4) Council considered the information that Jerry Perryman submitted to the P.U.C., a complaint alleging that he had been denied a meter. Council explained to Mr. Perryman it was not a case of won't, but can't put a meter in until the Grider Street project finishes up. This project has been financed and will start up and be constructed by the water company employees. The startup date will be a week from the evening of this council meeting. Meters will be allowed after a study has been made on his address. If that study shows there is pressure and the ability to increase capability for more meters there, he will receive a meter after payment is made. No motion was forthcoming.
- 5) A request by Falls County Appraisal district for electoral votes to be made for candidates to sit on the appraisal board was heard by Council. No motion was made. Comment during the discussion was that after all the years of taxation here in the city; the lease that candidates should apply themselves to is an introduction to the people that they are to represent. No motion, no votes.
- 6) Council heard from the city administrator on the progress of obtaining easements in order to start up the needed Old Bethany Road project, which will increase the water line to 8 inch for a 2 inch line. There is still a single hold out to the easement request. If that can be accomplished, the water company could possibly avoid a lawsuit from a person that is waiting for meter placement. No motion was necessary.
- 7) Council spoke with the Drews family of 4298 Box Ranch road. They are waiting for meter placement. They will be recipients of a meter when the Old Bethany Road project starts up, also. They wanted to

speak with the council, understanding the wait time. They also wanted to make the council aware that they have not started their home, but wanted to keep abreast of the timeline for meter considerations on the Bethany Project. No motion necessary.
